Hello assembly,

I cannot believe we are almost in September! It has been a busy month so let us dive right in:

#### **Update on Team RTZ Platform**

I have some extremely exciting statistics with regards to delivering on the actionable promises outlined in the official RTZ platform. Of our original 58 actionable items outlined, RTZ has made the decision to remove 8 of the items, bringing the total to 50. During the campaign period, there was a lot of background that we lacked and some of the actionable items had already been in place or were not feasible for the Alma Mater Society to commit to. Regardless, 50 actionable items remain strong and here are some of the statistics on our progress:

**Completed – 34 out of 50, 68%** 

Ongoing - 12 out of 50, 24%

How many left – 4 out of 50, 8%

In just under 4 months, Team RTZ has already delivered on 68% of the promises that we made to the Queen's undergraduate student body. In addition to some exciting projects that have not been announced yet, Team RTZ is proud of the work that we have accomplished alongside our extremely gifted team. I would like to note that our Senior Management team has truly made all of this happen, they are some of the most talented and passionate folks I have met at Queen's, and I am excited to see what the next 8 months has in store! For transparency, I will outline the last 4 actionable items that have not been touched yet:

- 1. Investigate Policy Papers and the possibility of their inclusion in student government at Queen's.
- 2. Weekly Executive updates to ensure that student body is aware of what actions the AMS is taking on at any given time.
- 3. Find, connect with, support individuals and groups involved with grass-roots movements. Facilitate their development into actionable change on campus.
- 4. Present plan to Board of Trustees regarding funding for professional mental health care and Student Wellness Services.

In the next few months, Team RTZ will ensure that these actionable items are a priority. All things considered; we are extremely proud of what has been accomplished.

#### **Budgets**



The budgets for the Communications, Marketing, Information Technology, and Human Resources Offices, were passed in the July session of the Board of Directors. This month, we will be submitting the Secretariat budget for approval which is exciting for my team.

#### **Student Choice Initiative**

Some very welcomed news for post-secondary student across Ontario: Ontario's Court of Appeal has dismissed the Ford government's bid to overturn an earlier decision that quashed its so-called Student Choice Initiative — a measure that sparked concern over the future of campus newspapers, student unions and other clubs and services. This is huge for the AMS and its affiliated Faculty Societies as we will be able to continue the same calibre of support to Queen's students without the looming fear that the Student Choice Initiative will return.

#### Fall Planning

I have had various meetings with the Queen's administration to get a better idea on what reopening the JDUC and AMS Offices will look like. We have confirmed that the JDUC will be open on August 30<sup>th</sup> to the public. Note that all club spaces will remain closed throughout September as AMS Event Sanctioning is not operating until October. The one exception to this is the Queen's University Muslim Student Association (QUMSA) Prayer Space, which will remain open for us beginning August 30<sup>th</sup>. Much of my role has been disseminating important fall-term planning information to other student leaders on campus and collaborating to ensure that the student experience is at its finest. The AMS Safety Plan has been under various iterations and is fully updated to adhere to the latest public health records.

#### AMS Marketing Campaign (Student Fee Increase)

Some background first: In the last 5 years, the AMS has grown significantly. With the addition of over 5 new permanent staff and lack of recover from the Student Choice Initiative in 2019, it is imperative that the AMS increase its fee slate. Such an increase must go to referendum and be voted on by the student body. The Marketing and Communications Team and I have completed the plan for a Student Fee Marketing Campaign set to be launched in late September/early October. We will be contracting Studio Q to create various editable templates that allow us the freedom to post digestible information regarding the AMS. Once templates are created, the team will move onto the content generation phase of the campaign. We are hoping to produce roughly 30 posts and 9 videos to be posted over the span of 3 months.

Dear Members of Assembly,

I think I say this every month but I truly cannot believe we are nearing the end of August. I'm sure the AMS is no different than all of you in that we are all gearing up for the start of the academic year. I hope you have a wonderful last few weeks of the summer! Below are some of my updates.

#### **Training**

Along with legislative and AMS-mandated training, each Service requires their own Service-specific training. The head managers have been working tirelessly on planning their training schedules. We have been approved for in-person training as long as we still continue to follow any and all public health orders. With that, some Services are scheduling training in shifts/groups, which adds another layer of complexity. Training begins next week for some of the Services and will continue into the first week of September. During these training weeks, many of the Services will either be closed or operating at reduced hours.

#### **Service Updates**

We are so excited to see the Common Ground lounge open! It is so nice to see both new and familiar faces spending time in the lounge every day, a welcomed sense of normalcy. Further to the lounge reopening, Cogro has also brought back their "for-here" dishes option for those dining in the lounge, rather than providing all food and drink in their single-use, biodegradable containers. Tricolour and the P&CC are getting operations in order to reopen their stores soon after the JDUC reopens to the public on August 30<sup>th</sup>! You can catch the Student Constables back in action in residences this year as well as helping with move in week and many other in-person events on campus as they gradually return. The Peer Support Centre has just reopened virtually this past Monday and we are working towards the hybrid model. The Food Bank continues to operate with a curbside pickup model and will do so into September. Walkhome will also continue to operate as is but will be closed for the last weekend of September. StudioQ has many commissions on the go, most notably a wedding photography commission this Friday! The Journal remains operating virtually with the hope of returning to the house regularly come September.

#### **Budgeting**



The Services and Offices have all completed their budgets. The Commissioners are nearing the end of their budgeting process and I am in the midst of completing the Consolidated Operating Budget along with our GM, Lyn Parry.

#### Hello everyone!

I hope your summers have been going great. Crazy that we are into September and that students will be soon back on campus. The Commission of External Affairs has been extremely busy with a vast array of projects.

#### OUSA (Ontario Undergraduate Student Alliance)

OUSA responsibilities within the commission have certainly begun to pick up. With the looming federal election happening mid-summer, the Steering committee has been heavy at work to determine our advocacy efforts moving into the fall as well as beginning the policy paper writing process for our general assembly in the fall. Within this, we most recently endorsed the Council of Ontario Colleges and Universities in their ask to the government to federally mandate vaccinations within all Ontario post-secondary campuses and were a key component in advocating Queen's to do the same.

#### <u>UCRU (Undergraduates of Canadian Research-Intensive Universities)</u>

UCRU has also been hard at work in establishing a vision for the year moving forward. With the federal election, we are looking into options to ensure that all students within our campuses can vote in their local ridings while remaining on campus at advanced polling stations. Within this, we are also currently planning our federal advocacy goals for our lobby week that is hopefully occurring once parliament is back in session.

#### **Academic Advocacy**

With the return of in-person learning in the fall, it has been an extremely challenging time for all surrounding the many intricacies of ensuring our students remain safe. At the AMS (Alma Mater Society), we have been in consistent conversations with the University Administration to ensure that all students can achieve accommodation throughout the year, as well as ensuring that all students feel safe for the return. We will continue to monitor the situation and adjust our advocacy efforts as things develop into the fall.

#### Academic Grievance Centre and Housing Resource Centre

Both Centre's under the CEA (Commission of External Affairs) are looking to reopen quickly into the fall to give students a peer-to-peer resource for all academic and housing concerns. As my assistant managers begin their roles next week, I am extremely excited to see how they develop and grow within their roles and all the wonderful things they will accomplish.

This has been an extremely busy time and I cannot thank everyone who I work closely with enough for being so supportive, could not do it without you folks.

I have been sitting in CRAG meetings the past couple of weeks to help move along in-person event approvals. For the fall, we will be updating the event sanctioning process to have its own step-by-step guide to completing online and in-person forms.

I have also been working closely with QUIC and Vice-Provost International to prepare for international student arrival in September. We want to ensure that students are hearing from all communication channels, receiving correct and consistent information. We understand that all international students are in distinct positions dependent on where across the globe they are returning from. We will be promoting the iCent app for arrival in Canada to hopefully alleviate the challenges of the quarantine process. The CAC will be opening its international student bursary in September for international students to receive financial support from the AMS.

I believe that it will be so incredible to have students back on campus and engaged more than ever in the safest manner possible. I am also looking forward to better supporting our

The Equity Affairs Manager Jenna Huys has been working hard on different SIC/committee collaborations and initiatives. The Gender Affirming Assistance Project recently launched to support two-spirit, trans, non-binary and gender diverse members of our community. The SIC and EQuIP will continue to support the development of this initiative.

They have also been working on the Mutual Aid Alliance, a cross campus partnership that will work with student groups and community members to address a lack of emergency financial aid to students.

#### Hello all!

I hope you're all having a great end of summer, and everything has gone well for you in your roles so far. The CES has been busy with many projects this summer, one of which was the Sustainable Action Fund. We received much more applicants than anticipated, and successfully allocated over \$9,000 towards sustainable, student-led initiatives. The dates have already been set for the next two allocation periods, in both the fall and winter, and we are very excited to support even more sustainable initiatives!

Additionally, the CES now has an Instagram account! Through this platform, we have been running sustainability-focused campaigns such as Plastic-Free July, Local Business of the Week, and giveaways with local partners. We're looking forward to seeing this account grow over time in order to further educate students on the importance of sustainability and the threat that climate change is posing to our planet.

This account has also been used to educate students on the problematic contract that Queen's has with Coca-Cola. The CES has partnered with the SIC on this advocacy project, with hopes of finding new criteria for the tendering process that emphasizes sustainability and ethical business practices. We are currently developing a student survey that will be put out next week, in order to better represent the student body in talks with the university. If successful, this advocacy project will provide support to the local economy, while also setting a precedent for future vending contracts at Queen's University.

This October, the AMS will lead the first ever Sustainability Month, which in the past was Sustainability Week. The month will consist of some very exciting speakers from all across the globe, as well as many other events run by our committee, external partners, and students from both Queen's and Saint Lawrence College. Stay tuned for further information on the CES Instagram account and reach out to me at ces@ams.queensu.ca if you wish to host your own event!

Lastly, the CES team will see two new faces come September 1<sup>st</sup>. The Deputy of Environmental Sustainability and the Deputy of Environmental Justice will be lovely additions to the team, and I'm excited to introduce them to you all!

#### **Events**

Annually, the QSAA supports and raises donations for a fund through Give to Queen's. The funds work toward supporting our fellow student community and highlighting the importance of philanthropy. This year, the QSAA has chosen to support two funds.
